



The Recreational Cup is the Washington Youth Soccer Championship Tournament exclusively for recreational teams. Each Region will hold preliminary rounds to determine who will represent Region 1 at State Quarter-Finals. Two games guaranteed in this tournament.

Region 1 preliminary games:

Will be held in October and November. Games could be scheduled at various locations from Seattle, to Oak Harbor or Bellingham. Once divisions/brackets are scheduled; and you are the home team, your club is responsible for game date/time/field/referees and will be responsible for all costs. Your club must approve your application. All preliminary games must be completed by November 21st.

State Quarter-Finals December 2nd or 3rd:

Will be held at various locations throughout the state. If you are a home team, Region 1 will schedule game and assign referees. Your club will be charged for these fees.

Semi Final and Final December 9th & 10th:

Will be at Star Fire in Tukwila and played on the same day except for U18/U19.

U11-U15 will play Saturday.

U16-U17 will play Sunday.

Who may enter?

The WYS Recreational Cup is ONLY open to recreational Boys and Girls teams U-11 through U-19 that are comprised of properly registered youth players affiliated with WYS Member Associations. U.S. Youth Soccer defines "recreational" by stating: "the use of tryouts, invitations, recruiting or any like process to roster players selectively to any team on the basis of talent or any ability is prohibited." If your team is playing in a competitive league (NPSL, RCL) you are not eligible for this tournament. See 2017 Recreational Cup Rules for further eligibility restrictions.
