

# WA YOUTH SOCCER RECREATIONAL CUP



The Recreational Cup is the Washington Youth Soccer Championship Tournament exclusively for recreational teams. Each Region/District will hold preliminary rounds to determine who will represent Region 1 at State Quarter-Finals. Two games guaranteed in this tournament.

## **Region 1 preliminary games:**

Will be held in October and November. Games could be scheduled at various locations from Seattle, to Oak Harbor or Bellingham. Once divisions/brackets are scheduled; **and you are the home team, your club is responsible for scheduling game date/time/field/referees and will be responsible for all costs for those games. Your club must approve your application.** When scheduling games you must accommodate the opponent's regular season schedule. No scheduling 2 games on same day of regular season game without consent of opponent. All preliminary games must be completed by November 21st.

## **State Quarter-Finals December 1st & 2nd:**

Will be scheduled at various locations throughout the state. If you are a home team, Region 1 will schedule game and assign referees.

## **Semi Final and Final December 8th & 9th:**

Will be at Star Fire in Tukwila and played on the same day.

U11-U15 will play Saturday.

U16-U17 will play Sunday.

Exception U18/U19 they will play semi-final on Dec. 8 and Final Dec. 9.

## **Who may enter?**

The WYS Recreational Cup is ONLY open to recreational Boys and Girls teams U-11 through U-19 comprised of properly registered youth players affiliated with WYS Member Associations, and playing in a WYS sanctioned league. U.S. Youth Soccer defines "recreational" by stating: "the use of tryouts, invitations, recruiting or any likeprocess to roster players selectively to any team on the basis of talent or any ability is prohibited."

If your team is playing in a competitive league (NPSL, RCL) you are not eligible for this tournament.
